
Please note that the download is free of charge.

The language of the mobile app is adjusted to the language set on your device and should be one of the following: English, Spanish, Polish, Romanian or Turkish. No registration is required and open access is provided to all users who want to use the app functionalities. If you create your own activities, they will be saved under 'Generated exercises'.



## What are FEMENIN e-learning nuggets?




E-learning nuggets are valuable topics on financial literacy tackled in the FEMENIN project. These include main ideas, learning objectives and glossary terms from all of the FEMENIN multilingual e-learning platform.

## What kind of exercises does the FEMENIN mobile app comprise?



You will find three different types of exercises: corporate finances, business travel and generated exercises. In the corporate finances section, you can do a 50-30-20 budget estimation, 50-30-20 after tax budget calculation, corporation tax calculation, check annual percentage rate and do a breakeven analysis. In the business travel section you can calculate exchange rates and business trip expenditure, and estimate business trip expenditure for the following year. Generated exercises are those created by you inside the app.


### How can I use the app generator?




Generator is the section within the app where you can create your own exercises. You can create your own tailored apps for the purpose of calculating budgets. For this purpose, you should enter a formula using the following signs + - \* / ( ) and using field codes (A, B and so on). Your personalised app will be listed in the Exercises section of the app under Generated exercises. Detailed instructions are provided inside the app.

### What is an example of an exercise that I can create myself?

Perhaps you want to check the minimum profit from a product sale. Try the calculation:




